The Phuentsholing Thromde Administration, would like to invite the interested parties and individuals to apply for setting up stalls during the Annual Phuentsholing Tshechu which is scheduled from 01/01/2026 to 03/01/2026. The detailed terms and conditions for stall allotment are as follows:

1. The application shall be submitted on or before 29/12/2025 and the application will be taken on first come first basis only for the number of stalls available as listed below
2. Interested individuals/parties shall report on 30/12/2025 at Phuentsholing Pelden Tashi Choeling Shedra at 10.00 am sharp for stall allotment.
3. A clearance fee inclusive of service charges as specified below shall be collected from each stall owner on the spot.
4. The location of the stall shall be on a lucky dip basis.
5. Plot sizes and fees are as follows:

Stall type	Size(meters)	Fees (Nu)	Location	No of slot

**Note:**

- ✓ Individuals are requested to bring/set up tents strictly as per the size of the area allotted.
- ✓ Tent Size larger than the allotted slot will not be entertained.
- ✓ Slot fees shall be paid/ collected on the spot after the lucky draw. Failure to pay the fees on the spot shall result in cancellation of the allotted stall, and it will be allotted to another individual through a lucky dip.
