1. The Royal Government of Bhutan has obtained financing from the Asian Development Bank (ADB) toward the cost of Climate-Resilient Omchhu River Protection Project. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Phuentsholing Thromde (“the Employer”) invites sealed bids from eligible Bidders for the Construction in the Omchhu River of counterfort RCC flood walls, riverbank protection (including increasing use of large rocks), check dams, scour protection for cross drainages, footpaths & cycling tracks along both riverbanks, and access ramp (“the Works”). The successful bidder should complete the Works within 36 months from the commencement date.
3. Open competitive bidding will be conducted in accordance with ADB’s single stage two envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
 - a) Bidder’s net worth for the last financial year calculated as the difference between total assets and total liabilities should be positive;
 - b) Minimum average annual construction turnover calculated as total certified payments received by the Bidders for contracts completed or under execution over the last three financial years should be Bhutanese Ngultrum (Nu) 434 million;
 - c) Bidder’s financial resources defined in FIN-3, less its financial obligations for its current contract commitments defined in FIN-4, meet or exceed the total requirement for the Subject Contract of Nu 72 million;
 - d) Participation as a contractor, Joint Venture partner, or Subcontractor, in contract(s) that has been successfully or substantially completed and that is similar to the proposed works, where the value of the Bidder’s participation equals or exceeds the amount given in table below within the period from 1 July 2015 up to the bid submission date.
